Dear Comrades,

I am enclosing herewith a letter received from the Board as regards holding of DPC for the cadre of ACIT and steps to redress the issue of stagnation that exists in the cadre of ITO. The Board vide aforesaid letter intimated the Central JCA that the proposal for DPC for 180 posts against the Recruitment Year 2014-15 will be sent to the UPSC by 27.10.2015 and the deficiency list of APARs required for holding the DPC for the Recruitment Year 2015-16 has already been uploaded in Departmental website. The Board further intimated that it will undertake the necessary action in time bound manner once the decisions are taken in the ensuing meeting to be held with the Revenue Secretary and JCA on 03.11.2015 to address the issue of stagnation in the cadre of ITO. In the light of discussion held with the Chairperson, CBDT on 20.10.2015 and the letter dated 26.10.2015, the Central JCA met today to discuss and deliberate upon the issue of the proposed suspension of agitation. The meeting decided to postpone the Dharna programme to be held in front of the residence of the Chairperson on 28.10.2015 and the meeting was adjourned to 27.10.2015 without taking any further decision. It is felt that to create a conducive atmosphere to negotiate with the Revenue Secretary, GOI, in the issue of determining the correct vacancy calculations in the cadre of ACIT for the R.Y.s 2013-14 to 2015-16 and removing stagnation in the cadre of ITO created due to less number of posts sanctioned in ACIT cadre in the CRC, 2013, it may perhaps be necessary to scale down the ongoing agitation by partial suspension till the meeting scheduled on 03.11.2015. Accordingly you are requested to express your views by forenoon of 27.10.2015 enabling the CHQ to take the views of ITGOA to the adjourned JCA meeting.


Subject: The pending issues of JCA-the call for Agitation-intimation reg.

Sirs,

I am directed to refer to your letter N-1/2015-16 dated 12.10.2015 on the above cited subject. The issues raised by the JCA (ITEF & ITGOA) have been considered time to time and deliberated in the meetings of PGRC/ QRM on 10.06.2015, 11.02.2015 and 21.07.2015, respectively. The Board has again given due consideration to your demands and proposes the following course of action:-

- (i) Proposal for holding a DPC meeting for promotion of ITO to ACIT to fill up 180 vacancies for the panel year 2014-15 is being submitted to UPSC by 27.10.2015 after fixing meeting with officers of UPSC under single window.
- (ii) Similar exercise for preparing a proposal for promotion of ITO to the post of ACIT to fill up 180 vacancies against the vacancy year 2015-16 has been commenced. The list of deficient ACRs in respect of ITOs in the zone of consideration for vacancy year 2015-16 has already been placed on the Departmental website. Once the deficiency is removed the proposal for the vacancy year 2015-16 will be firmed up and submitted to UPSC on priority.
- (iii) To address the issues relating to stagnation in the cadre of ITO, a meeting is scheduled to be held by Revenue Secretary with the JCA on 03.11.2015. Necessary follow up action would be taken on the decisions to be taken during the meeting, in time bound manner.
