Comrade,

Blatant anomalies have been noticed in the Annual General Transfer Orders for the cadre of JCIT/Addl.CIT and ACIT/DCIT. These anomalies are required to be brought to the knowledge of the concerned authorities immediately for necessary redressal. The anomalies/aberrations noticed in the orders are narrated below for immediate action at your end.

- i. It is seen that the authority has totally overlooked and ignored most of the representations of the promotee officers, the reasons for which are only best known to them.
- ii. At least 14(fourteen) ACsIT from WB region, posted in other regions, who have completed the cooling off period of 24 months as on 01-01-2013 have not been considered in this order, which is a blatant violation of the existing transfer policy.
- iii. 24(twenty four) ACsIT who had been posted in WB region in cross-country transfer of AGT-2012 had submitted representations for postings in their neighbouring states which were not at all considered.
- iv. Officers, both in the cadre of JCIT and ACIT, who were retained in the last AGT on the basis of compassionate grounds and deficiency zone have now been transferred and suddenly the earlier grounds are overruled. The transfer order of officer which got cancelled in the earlier AGT has once again been reinforced in this order. Such lack of consistency in matters of transfer is not in keeping with the spirit of the Policy.

In this connection, kindly note that in case of posting order of the DR officers in the cadre of ACIT effected in the recent past, representations of the officers had been considered favourably in almost all the cases.

It is beyond our comprehension as to how the Transfer Policy can be violated so rampantly, which had been formulated after prolonged deliberations. It degenerates the chair of the authority for failing to abide by the accepted norms and disregards the sanctity of our organisation.

This has indeed created an atmosphere of resentment and frustration amongst the members of this region.

In view of the above, you are requested to pursue the matter with the appropriate authority so that the transfer of the officers be effected strictly as per the policy set up for the purpose giving due consideration to the compassionate/humanitarian grounds. As we are told that the matter will be discussed by the Grievance Redressal Committee on 04-06-2013, the extension of the date of release beyond 31-05-2013 is to be taken up at the proper level immediately.

We request an early action on your part.
