Subject:- Implementation of N.R. Parmar judgment of Hon'ble Supreme Court- reg.

Sir,

I am directed to refer to the judgment dated 27.11.2012 of Hon'ble Supreme Court in N.R. Parmar case which has to be implemented by adopting the procedure of holding review DPCs for promotion from ITI to ITO in all the regions. For the purpose of consideration of ITOs for promotion to the grade of ACIT an all India inter-seniority list of ITOs has to be prepared on urgent basis. The full-fledged implementation of N.R. Parmar case has already over delayed and a further delay may cause delay in further promotion to ACIT and lead to contempt of court cases in various Courts/Tribunals.

2. Therefore, you are requested to furnish a copy of revised seniority list of Income Tax Officers (along with soft copy) w.e.f RY 1986-87 after implementation of judgment of Hon'ble Supreme Court in N.R. Parmar case in the prescribed proforma given hereunder -
