Respected Madam,

Sub: Transfer of officers in the grade of ACIT/JCIT to and from West Bengal charge on the grounds of completed cooling off period of 24 months and education ground – request for.

We congratulate you on your elevation as the Chairperson, Central Board of Direct Taxes, and wish that your tenure as the Head of the Income Tax family will usher a new era in the functioning of Income Tax Department.

We would like to inform you that 14 officers, as per enclosed list, have been transferred out of West Bengal on promotion to the grade of ACIT as per the clause 3.4 of transfer/Placement guidelines for officers of Indian Revenue Service, CBDT and completed 24 month of cooling off period. As per the Clause 4.8 of Transfer/Placement guidelines formulated by CBDT in 2010 the minimum cooling off period for being posted again to the same station/region is 24 months reckoned from the joining at the new station and was consistently followed by CBDT by transferring back the officers to the same region by passing the Annual General Transfer Orders in 2010, 2011 and 2012. Unfortunately, none of these officers has been transferred back to West Bengal as per the AGT Order No. 86 of 2013 passed on 24th May, 2013. Another ACIT who is posted in WB charge from other State and completed the cooling off period of 24 months did not find his name in this year's AGT.

Further two officers who have recently been promoted as ACIT vide CBDT's Order No. 83 of 2013 dated 13-05-2013 have school going children who will be appearing in the Board Examination (Class X) scheduled to be held in 2014 and their cases have not been considered for retention in West Bengal. Another officer, figuring her name in the same list of promotion, is yet to accept promotion and represented for retention in WB charge on medical ground.

In the cadre of JCIT also, one JCIT is posted in WB charge from other State and completed the cooling off period of 24 months but did not find his name in this year's AGT. Another JCIT, transferred out of WB charge vide order no. 87, dated 24-05-2013, has school going children who

will be appearing in the Board Examination (Class X) scheduled to be held in 2014 and his case have not been considered for retention in West Bengal.
