**Sub: AGT, 2016 in the cadre of Addl. CIT/JCIT and DCIT/ACIT- request regarding.**

While appreciating that the process of AGT, 2016 has already been initiated, we would like to place some of the issues concerning our members in Addl. CIT/JCIT and DCIT/ACIT cadres to be considered by the CBDT.

- I) The cooling off period of 2(two) years, including the postings in Directorates and IT & TP, to be reckoned from AGT to AGT, as was done in the cadre of DCIT/ACIT in the AGT, 2015.
- II) All officers, transferred out of their home stations in 2013, 2014, 2015 and earlier years may kindly be sent back to their home-stations, if options/ requests are given accordingly.
- III) Officers are to be transferred out of their home stations if only there are no vacancies in that region and/or the officers have sought for their transfers out.
- IV) The officers who are to be transferred mandatorily out of their Home Stations may be posted in the nearest available station of posting, if the options are not exercised otherwise.
- V) All the cases of the officers retiring on superannuation within 3 years may be considered for placements in their home regions, if not the options are exercised otherwise.
- VI) All the officers forwarding requests of postings on the ground of 'Differently able Dependents', may be considered vide DoPT's OM No. 42011/3/2014-Estt ( Res) dated 06.06.2014 and posted at their 1<sup>st</sup> choice of postings.
- VII) All the Lady-officers who are in the zone of transfer may be retained in their home stations, if opted for.
- VIII) All requests of postings on Medical/Education (both 10<sup>th</sup> and 12<sup>th</sup> Standards) grounds may be considered at their 1<sup>st</sup> choice of postings.
- IX) All requests of postings on spouse grounds may be considered sympathetically.
- X) The Principal Office Bearers (President, General Secretary and Treasurer) of the State/Regional Units of ITGOA, who are in the zone of transfer, may be allowed to continue at the same region/station, if the options are not exercised otherwise.
- XI) The respective regional Pr.CCsIT may be allowed to place officers in the Directorates of CBDT, including the postings in the IT & TP, following the T & P norms of that region.

**The representatives of ITGOA may be given an opportunity to meet and explain you the above-mentioned issues.**
