Sub:- Redressal of Public Grievances on CPGRAMS

In the present Government regime the delivery of efficient services to the Citizens and redressal of their grievances has assumed greater significance for all the union Ministries and Departments. The grievances pertaining to Income Tax Department are monitored by the Department of Administrative Reforms & Public Grievances (DARPG). The hon'ble Prime Minister of India periodically reviews through PRAGATI interactions the progress of resolution of grievances received on CPGRAMS Portal. He has desired that all the Ministries/Departments should step up to resolve the grievances within 30 days of the receipt in the respective Ministries/Departments.

While we have progressed remarkably in the area of redresal of grievances, we are failing to bring down the time taken for this matter. The following table depicts the status of grievances as on 15.05.2017, downloaded from CPGRAMS Portal.

It may be seen that we still have quite long pending grievances to meet the target set by the Prime Minister and communicated by the Chairman, CBDT from time to time. The Central Action Plan for the first quarter of Financial Year 2017-18 expects us of clearing of all the grievances pending for more than 60 days. The Citizens' Charter also casts obligation on the Department to ensure resolution of grievances within 60 days.

Though the efforts made by the officers and the field cannot be undermined, there are still some offices failing to give adequate attention to this area of work, resulting in poor reflection on the image of the Department. After the analysis of the reasons for delay it is often noted that the officials monitoring the grievances fail to correctly identify competent officer to handle a particular grievance. Sometimes, the grievances remain unattended to. When the monitoring offices put pressure to quickly resolve the grievances, those are pushed from one jurisdiction to the other without proper application of mind. In so far as determining the age of a grievance is concerned, it is reckoned from the date of receipt in CBDT.

The Directorate of TPS-II has prepared a sub-ordinate wise list of grievances pending for more than 60 days and 90 days as on 15.05.2017. The same is enclosed herewith for necessary action. The field formation is directed to immediately tone up its functionaries to achieve the Action Plan target. It is suggested that no grievances should be allowed to age past 30 days in future to see Nil pendency in the higher age brackets.
