1. **Status of Promotion**

ITO to ACIT for R.Y. 2013-14

The matter has been referred by CBDT to Department of Legal Affairs as advised by UPSC to seek opinion on whether holding DPC from the existing seniority list of ITOs subject to revision of seniority of ITI or ITO based on the judgment of hon'ble Supreme court in N R Parmar. Further it came to our knowledge that the DOLA has referred back the file again to the Board for obtaining views of DOPT. Further the UPSC has pointed out deficiencies in dossiers of few officers coupled with indifferent attitude of CBDT which are all contributing to the delay in promotion. The CHQ has been pursuing the matter at all levels in CBDT as well as other agencies involved in the process. In fact Revenue Secretary has also been apprised of the situation in our meeting with him on 28<sup>th</sup> April, 2014 on the issue. **The memorandum submitted to Revenue Secretary is enclosed.** We are going to discuss the issue threadbare in our Secretariat meeting to be held on 04.05.2014 and will meet The Board again to demand urgent action from the Board for immediate holding of DPC for the year 2013-14.

As we have intimated you earlier that the issue of DPC for CRC vacancy for RY 2013-14 & 2014-15 and regular vacancy for RY 2014-15 were already taken up with the CBDT and requested the Board to initiate the process immediately. We are hopeful that process will start once the DPC for the regular vacancy for RY 2013-14 is completed.

NFSG to 2001 batch

Finally the CBDT has called for vigilance clearance and APAR grading for granting NFSG to the left out officers of 2001 batch from 01.01.2014. We are pursuing it on regular basis to have the order of promotion passed early.

## **2. Transfer & Posting**

The Placement Committee Meeting for posting of the JCSIT, promoted on ad-hoc basis in Sep-October, 2013, has been done recently. We find no rhyme or reason for doing posting orders in isolation while the AGT, 2014 is expected to be done soon. The matter has been officially intimated to the Revenue Secretary along with other anomalies and discriminations faced by the promote officers in various posting orders and his kind intervention has been sought for. As regards proper Transfer & Posting Policy and its implementation, a detailed memorandum has been submitted to the Revenue Secretary.

## **3. CCGGOO**

At the initiative of ITGOA, CHQ a convention of CCGGOO was successfully held in New Delhi on 17<sup>th</sup> April, 2014 to take up issues before VII Pay Commission. The Convention, apart from discussing various issues relating to Group-B officers, had also selected Shri. S.Mohan, as the Convenor, Shri.Bhaskar Bhattacharya as the Joint Convenor, and Shri. Raman Kumar Sharma as core committee member till the Conference. It was also decided to hold Conference at Kolkata in the month of June, 2014. **Detailed Circular of CCGGOO already circulated for your information. The VII CPC has circulated a questionnaire which is attached herewith for the consumption of all our members.**

## **4. Meeting of the Secretariat & JCA**

It was decided to hold Secretariat and JCA meeting on 04.05.2014. Respective notices in this respect have already been issued. We will discuss all the issues affecting the career prospects of our members and reviving the functioning of JCA in order to make it an effective tool for bargaining of our issues.
