**Sub :** Grant of next higher pay matrix i.e., from Level 8 to Level 9 on completion of 4 years regular service at the post of AO, Gr.-II – matter regarding.

The undersigned is directed to convey that as per the information received from the DCIT, Hqrs. (Admn. & Vig.) Kolkata vide letter in F. No. 2E/28/NFSG(ITO)/2018-19/8912, dated 31.12.2018 the officers named in the table below have been promoted to the post of 'AO, Gr-II' vide order no's & dates mentioned in the table qualify for grant of next higher pay matrix i.e., from Level 8 to Level 9 on completion of 4 years regular service at the post of AO, Gr-II in the Department.

In terms of communication from ITO, CMD-II, (HRD), CBDT, New Delhi vide F. No. HRD/CMD/175/7/2016-17/5071, dated 30.11.2018 the officers named below may be granted the next higher pay matrix i.e., from Level 8 to Level 9 w.e.f the respective date of completion of four (4) years of regular service in the post of AO, Gr-II, if it is found by their respective Head of Offices that the officers have completed four (4) years of regular service in respective posts irrespective of the pay scale attached to the post, and this enhancement of pay has not been granted earlier.
