ORDER No. 63 of 2016

(ii) Such appointments shall be subject to the outcome to the judgement of the Hon'ble Supreme Court in SLP (C) No. 21339/2012 (Vikas Keraba Suryavanshi & Ors.-vs- UoI & Ors.);

(iii) These will not confer any right or equity in favour of the appointees.


