## Sub:- Decision of the Sectt. Meeting dated 04.12.2019

Secretariat Meeting of the ITGOA, CHQ was held at New Delhi as per Notice dated 22.11.2019. The meeting discussed the agenda items mentioned in the notice and decided as under:-

- While reviewing pending issues the meeting identified the following issues where immediate actions needed to be taken.
  - a) Senior Time Scale to 2014-15 Batch of officers
  - b) Annual General Transfer
  - c) Arbitrary use of Rule 56(j)

After threadbare discussion it was decided as under :-

- Letter will be written to the Board for invoking Rule 14 of the IRS Recruitment Rule, 2015.
- To hold Lunch hour demonstration on 12.12.2019 under the banner of JCA.
- iii) To write to the Board expressing the anguish/resentment of the members over the above issues. It was further decided that if the Board does not take any action, facts will be intimated to the higher authorities such as Revenue Secretary, MOS(Finance) and Finance Minister.
- iv) It was also decided that even after adopting the above steps if there is no development, media will be briefed through press meet, using tweeter account etc.
- After exhausting the above steps, further course of action will be decided in the JCA.
- Cadre Restructuring: The house was briefed about the CRC-2019 and the methodology adopted by the CRRC. It was also intimated that submission from the JCA was made in the line of decision of the Bhubaneswar MCM. It was also informed that though the report was in the final stage in the month of September, 2019 but the same

- was deferred due to implementation of e-assessment scheme i.e. creation of NeAC and ReAC. The house after discussion suggested to demand creation of the post of JCIT(Appeals) as the ratio of JCIT and ACIT needs to be maintained.
- 4. NeAC & ReAC :- It was informed to the house about the outcome of te meeting with the Chirman, CBDT with the JCA representatives of the 8 Units held on 15.11.2019. After discussion it was felt that though as per the decision, a compiled letter was submitted to the Chairman, CBDT on 20.11.2019 specifying the grievances but there was no further improvement have been observed. Accordingly it was decided to write a letter to the Chairman, CBDT informing him that no action was taken till date.
- 45th All India Biennial General Body Meeting: It was decided to hold the 45th Biennial General Body Meeting from 16.01.2020 to 18.01.2020 at Kolkata. The Managing Committee Meeting will take place in the evening of 15.01.2020. Formal notice will be issued accordingly.
- 6. All India Strike :- It was informed to the house that a request was received from the ITEF on 07.11.2019 requesting us to participate in one day strike action on 08.01.2020 in support of the 10-point charter of demand. The house decided to participate in the strike action as per the decision of the Bhubaneswar MCM decision. Accordingly, joint strike notice will be served on 12.12.2019
