Madam,

Sub: Protest against indifferent attitude of the local administration towards the genuine demands of the employees and officers – Grievance reg.

Kindly refer to the meeting we had with you in your chamber on 04/09/2018. In the said meeting a number of issues concerning the members of JCA in this region were discussed. We are thankful to you for appreciating the genuineness of our grievances over these unsettled issues. You would recall that you had assured that you will get back to the JCA after taking feedback on the status of the pending issues from the officers in your administration. We are very disappointed that we have not received any further communication from your end regarding developments made by your administration for sorting those pending issues. In fact, the JCA on its own volition had approached you on 11/09/2018 but failed to get an audience from you.

We are compelled to mention here that the O/o the Pr. CCIT, WB & Sikkim, is maintaining an anti-employee face for long. Showing indifference and spreading an apathetic attitude towards the just issues of officers/officials have become the order of the day and so, the discontent amongst our members has reached its peak. Under the circumstances, we have no alternatives but to tread the path of agitation demanding immediate action from the administration on the following demands:

- i) Pending promotion of Group B & Group C cadres for the Recruitment Year 2017-18 and 2018-19.
- ii) Compassionate appointment for Recruitment Year(s) 2015-16, 2016-17 & 2017-18.
- iii) Protest letter to be lodged to the CBDT against the proposed diversion of post from WB & Sikkim Region to ITAT, Surat.
- iv) Modification/rectification of the aberrations made in the Transfer & Posting orders in the cadres of Addl./Jt. CIT., ITOs, Sr.PS, AO, Inspector of Income Tax.

The JCA in its meeting held on 17/09/2018 has unanimously decided to observe one day 'Cease work' throughout all the offices in West Bengal & Sikkim on **27/09/2018** as a token of protest before launching more intense agitations in near future.
