Dear Secretary,

Kindly refer to my D.O. letter of even number dated 30<sup>th</sup> April, 2015 regarding furnishing of information relating assets and liabilities by Public Servants under provisions of Section 44 of the Lokpal and Lokayuktas Act, 2013 and forwarding therewith copies of the Government of India Notifications dated 27<sup>th</sup> April, 2015.

2. In this regard, I am now forwarding herewith a copy of the Government of India Notification dated 03<sup>rd</sup> July, 2015, further amending the Public Servants (Furnishing of Information and Annual Returns of Assets and Liabilities and Limits for Exemption of Assets infoling Returns) Amendment Rules, 2015.

3. In view of the aforesaid notification of Public Servants (Furnishing of Information and Annual Returns of Assets and Liabilities and Limits for Exemption of Assets in filing Returns) Second Amendment Rules, 2015, the timelines for filing of returns/declarations, specific to different years, by public servants under the Lokpal and Lokayuktas Act, 2013, are as follows:

- a. the first return (as on 1st August, 2014) [as was initially required to be filed by 15th September, 2014] can now be filed by 15th October, 2015.
- b. the annual return (as on 31st March, 2015) [as was initially required to be filed by 31st July, 2015], can now be filed by 15th October, 2015.

whate to c. the subsequent annual returns (as on 31st March of each year) are required to be filed by 31st July of that year.

In view of the above, I would like to request you to kindly bring the above mentioned position to the notice of all concerned and to issue orders towards ensuring compliance with these rules by all officers/staff in your Ministry/Department and organisations/PSUs under the control of your Ministry/Department.

सा.का. लि. 536(अ).— केन्द्रीय सरकार, सोकपान और लोकायुक्त अधिनियम, 2013 (2014 का 1) की घारा 44 और घारा 45 के साथ पठित घारा 59 की उपघारा (2) के संड (ट) और घंड (ठ) द्वारा प्रवत्त शक्तियों का प्रयोग करते हुए, लोक सेवक (सूचना और आस्तियों तथा दायित्लों की विवरणी बेने सथा विवरणियाँ काइल करने में आस्तियों की छूट के लिए सीमाएं) नियम 2014 का संशोधन करने के लिए निम्नसिखित नियम बनाती है, अर्थात् :---

1. (1) इन नियसों का संक्रिप्त नाम लोक सेवक (सूचना और आस्तियों तथा दायित्वों की विवरणी देने तथा विवरणियाँ फाइल फरने में आस्तियों की सूट के लिए सीमाएं) धूसरा संशोधन नियम, 2015 है।

(2) ये उनके राजपत्र में प्रकाशन की तारीख से प्रवृत्त होंगे।

2. लोक सेवक (सूचना और वास्तियों तथा दायित्वों की विवर्णी देने सया विवरणियाँ फाइल करने में वास्तियों की छूट के लिए सीमाएं) नियम, 2014 के नियम 3 में, उपनियम (2) के पश्चात् निम्नसिक्ति परंतुक बंतःस्थापित किया जाएगा, अर्थात्:—

परंतु यह और कि ऐसे लोकसेवक जिन्होंने ऐसे लोकसेवकों को लागू नियमों के उपबंघों के बधीन संपत्ति की घोधणा, सूचना और उन्दर्शिक रिटर्न फ़ाइल की है, यचास्थिति पुनरीक्षित घोषणा, सूचना या बार्क्कि रिटर्न 31 मार्च, 2015 की स्थिति के बनुसार सक्षम अग्निकरी को 15 बक्तूबर, 2015 को या उससे पूर्व फाइल करेंगे।"

## MINISTRY OF PERSONNEL PUBLIC GRIEVANCES AND FENSIONS Operations of Personnel And Training Settification

New Delhi, the 3rd July, 2015

G.S.R. 536(E).—In exercise of the powers conferred by sub-section (1), clause (k) and clause (l) of sub-section (2) of section 59 read with section 44 and section 45 of the Eologal and Eoksynkrik Act 2013. (1 of 2014) the Central Government hereby makes the following rules further to amend the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, namely:—

1. (1) These rules may be called the Public Spryants (furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Second Amendment Rules, 2015.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rolles, 2014 in full 31 sub-rule (2), the following proviso shall be inserted, namely -

"Provided further that the public servants who have filed declarations, information and annual returns of property under the provisions of the rules applicable to such public servants shall file the revised declarations, information or as the case may be, annual returns as on the 31<sup>st</sup> day of March. 2015, to the competent authority on or before the 15<sup>th</sup> day of October, 2015."
