Subject - Enhancement of Sectoral Display - FM OLTAS Dashboard -reg

Sir/Madam,

As you are aware, the field formations (CCsIT and above, CsIT (TDS) etc) were provided with access to the FM OLTAS Dashboard at the URL <https://onlineservices.tin.egov-nsdl.com/TIN/JSP/security/LoginForFM.jsp> to view taxes paid by the top taxpayers. This view was generated from a list of 1000 company PANs which were extracted in 2011.

2. This Top taxpayer list facility has been enhanced as under:
 - i) The selection of sector and sub-sector has been made consistent with the I T return form.
 - ii) An exhaustive list of around 62,000 PANs spread over all sector/subsectors (maximum of top 1000 PANs for each sub-sector) has been utilised for identifying the top taxpayers. As a result more number of cases will be visible under each sector and sub-sector.
 - iii) The top taxpayers from non corporate category (including proprietary concern, HUF, Firm, AOP etc.) are also included.
3. The above may kindly be communicated to the field formations. This instruction is also available at i-taxnet.
