**CIRCULAR**

**Sub. :** Circulation of revised Final Seniority list in the cadre of Administrative Officer, Grade-II pertaining to panel/vacancy years 2013-14 to 2016-17, in the region of West Bengal & Sikkim – matter reg.

In view of the Hon'ble Apex Court Judgement in the case of Union of India & Ors. Vs. N. R. Parmar & Ors (Civil Appeal No.7514-7515 of 2005) dated 27.11.2012 and in pursuance of the DoP&T's OM No 2011/1/2012-Estt (D) dated 04.03.2014 read with the CBDT guideline dated 29.09.2014, 07.11.2014 and 16.01.2015, the seniority list in the grade of Office Superintendent was revised in this region from the Vacancy Year 1998-99. Subsequently, the seniority list in the grade of Administrative Officer, Grade-III was also revised for the Vacancy Years 2004-05 to 2016-17.

In view of such revision in the grade of AO, Grade-III, which constitutes the feeder grade for promotion to the grade of Administrative Officer, Grade-II, the panels for promotion to the grade of Administrative Officer, Grade-II drawn up in the past pertaining to Panel/Vacancy years 2013-14 to 2016-17 was revised by conducting review DPCs.

On the basis of such revision, the **revised tentative seniority list** in the grade of **Administrative Officer, Grade-II** pertaining to this region relevant to **the Panel/Vacancy Years 2013-14 to 2016-17** was notified as per the approval of Competent Authority vide F. No.E-3/3/Pr. CCIT,WB & Sikkim/AO/17-8/13817 dated 05.09.2017, seeking objections, if any, in connection with the aforesaid tentative seniority list from the officers concerned on or before 15.09.2017 .

No objection has been received on or before the scheduled date (15.09.2017) in respect of aforementioned tentative seniority list of AO, Grade-II pertaining to Vacancy Years 2013-14 to 2016-17.

The **revised final seniority list** in the grade of **Administrative Officer, Grade-II** pertaining to this region relevant to the **Panel/Vacancy Years 2013-14 to 2016-17** is hereby notified as per approval of Pr. Chief Commissioner of Income Tax, West Bengal & Sikkim.

It may be stated that the cadre of Administrative Officer, Grade-II is a 100% promotional cadre and rota-quota method is not applicable in this cadre.


