**Sub:- Redressal of Grievances on CPGRAMS Portal -request:-reg.**

**Ref:** CBDT Chairman DO No.Dir(Hqrs.)/Ch.(DT)/39(2)/2015 dated 24.04.2017.

Kindly refer to the above.

The Hon'ble Chairman CBDT has desired the field formation to resolve the grievances pending for more than 60 days on CPGRAMS Portal within a week of the date of the issue of the above DO letter. In this context, it is clarified that the age of a particular grievance is to be counted from the date of its receipt in the Board. While speaking to the officers it is observed that the field formation takes the age of the grievances from the date when it is received in the concerned office. The Department of Administrative Reforms and Personnel Grievance (DARPG) considers the age of the grievances from the date of receipt in CBDT. Similarly, in the PRAGATI Meetings the Hon'ble Prime Minister also reviews the progress of the disposal of the grievance from the date of receipt in the CBDT.

It is worthwhile to reiterate here that the Hon'ble Prime Minister has desired the Redressal of grievances within 30 days of the date of its receipt in the CBDT

While monitoring the grievances the following reasons are observed for the delay in disposal of the grievances:-


- (i) The nature of the grievances is not properly studied by the handling official leading to avoidable confusion as to how the matter can be attended to
- (ii) It is often seen that there is a confusion with regard to the officer competent to resolve the grievance. When there is pressure from the monitoring authority, the grievances are pushed from one section to the other; without due application of mind.
- (iii) Sometimes, the grievance of the petitioner is not substantiated and the officer handling the grievance writes a letter to the petitioner. The petitioner either does not comply with the requisition sought for, by the officer or unduly delays the compliance.

The above observations are only illustrative and not exhaustive.

I had a meeting with the Addl. Secretary (Revenue) on 24<sup>th</sup> April, 2017. He asked me to make the field aware that all the grievances pending for more than 60 days should be reduced to Nil within a week. I have been contacting the officers to meet the target indicated above. I find that there is little progress at some of the places. I humbly request Hon'ble Officers of the Department to kindly devote necessary time for meeting the target of the resolution of grievances. The list of the grievances pertaining to respective regions as on 01.05.2017 is enclosed herewith for convenience.
