Subject: Additional charges to be held in respect of posts created in Restructuring.

Sir,

During the course of meeting taken by Chairperson, CBDT today, it was decided that the officers at the grade of CCIT, Pr. CIT and CIT should be put in place by assigning additional charges in respect of the newly created posts for which jurisdiction orders have already been issued by the Board. It would be appreciated that in the absence of Officers manning these posts, the administrative and statutory functions cannot be discharged. It is also possible that due to the large scale of re-organization of jurisdiction, designations of some officers have to be changed to fit them into the jurisdictions which largely correspond to their old jurisdiction. This would be true of all the Cadre Controlling regions where new posts have been created at a particular grade.

2. I am enclosing copy of format created in Mumbai region for Pr. CIT - level which can be used as a template for your region also. You are requested to map the old CIT jurisdiction with the new Pr. CIT jurisdiction and to suggest the names and civil code list number of the Officers (in column nos. 9 and 10 of the format) who can be given

additional charge over the newly created charges/regions. The additional charge should be proposed so as to ensure that the existing incumbents continue to exercise jurisdiction over the cases in the new jurisdiction also to the maximum possible extent. I would request you to provide this information for Pr. CIT – level posts in the prescribed format in an Excel worksheet by e-mail at debjyoti.das@nic.in. This information may be provided by e-mail latest by 11.11.2014.

3. Similar proposal may also be made in respect of CCIT and CIT – level posts separately for your region.

4. A video conference will be held by Member (P&V) and the undersigned on 10.11.2014 (Monday) at 3:00 P.M. with the Pr.CCIT/CCIT (CCA) of all the regions to discuss this matter. You are requested to kindly participate in the same.
