**Sub:**

- i) Ad-hoc promotion in the cadre of ACIT against the vacancies of the R.Y. 2014-15,**
- ii) Final Deficiency List of ITOS for the promotion against the vacancies of the R.Y. 2015-16,**
- iii) Ad-hoc promotion from DCIT to JCIT for the 2006/2007 batches,**
- iv) STS promotion for the 2011 and earlier batches,**
- v) The Annual General Transfers 2016 – compilation of list of options exercised – request for information**

Please refer to the above.

- i) You all know that the proposal for the regular DPC for promotion in the cadre of ACIT against the vacancies of the R.Y. 2014-15 was submitted to the UPSC on 11-12-2015. But the UPSC is yet to finalise the date of DPC due to various Court cases against holding of the DPC and has again sent a query to the CBDT to be replied after taking sanction from the DoPT and DoLA. Even the intervention of the Revenue Secretary, GOI, along with the Member (P & V), CBDT, as they met the Chairman, UPSC, on 23-03-2016 to get an early date of DPC could not yield result in holding the DPC by 31-03-2016.  
In such a scenario, taking into account the immense frustration amongst the members of ITGOA across the country and also, the opinion of most of its constituent Units, the CHQ had decided to request the CBDT to go for the ad-hoc promotion immediately. The CHQ took up the issue of ad-hoc promotion with the competent authorities on 28-03-2016 and the CBDT

and the Revenue Secretary, GOI, were convinced. The Revenue Secretary has accorded his kind approval on 30-03-2016 for holding Ad-hoc promotions for the vacancies of the R.Y.s 2014-15 & 2015-16 immediately. The fresh vigilance clearance was asked for on 29-03-2016 and the Ad-hoc DPC for 200 vacancies against the R.Y. 2014-15 has been convened by the CBDT on 31-03-2016. As the order of promotion requires the kind approval the Hon'ble Finance Minister, GOI, and as he is not in the country till 02-04-2016, the order may be expected only on 04-04-2016.

It has also been decided that the Ad-hoc DPC for 200 vacancies against the R.Y. 2015-16 will be convened by the CBDT in another week's time, if the deficiencies in APARs can be removed by then.

As also decided, the approval of DoPT and DoLA has been sought for by the CBDT to reply the query of the UPSC in favour of holding the regular DPC for the R.Y. 2014-15 immediately. The Revenue Secretary has expressed his kind intention to expedite the process and the CHQ is pursuing the matter in day-to-day basis so that the regular DPC is held without any further loss of time. Also, the Central JCA had the opportunity to meet Sri Jayant Sinha, the Minister-of-State (Finance), on 31-03-2016 and requested him to take up the issue of regular DPC with the UPSC. The Hon'ble MoS (Finance) has agreed to pursue for immediate regular DPC of the R.Y. 2014-15 to the Chairman, UPSC, as soon as the sanction of DoPT/DoLA is obtained.

The proposal for the regular of DPC for the R.Y. 2015-16 will also be forwarded to the UPSC and the process of preparing the proposal of DPC for the R.Y. 2016-17 will be initiated as soon as the Ad-hoc DPC for the R.Y. 2015-16 is held.

- ii) **The final Deficiency List of ITOS for the promotion against the vacancies of the R.Y. 2015-16 is attached herewith.** All the Units of ITGOA are requested to remove the deficiencies, as per the list, by 05-04-2016 and send the requisite documents to the Board. It is also requested to all the Unit leadership to **send the documents positively through messenger and not by post** to save time and help the Ad-hoc DPC for the R.Y. 2015-16 to be held as soon as possible.
- iii) The order for the Ad-hoc promotion from DCIT to JCIT for the 2006/2007 batches was passed on 21-03-2016. But 42 officers of the same batches were left out due to the reasons of vigilance withheld, Below Bench-mark APARs and deficient APARs. The issue was taken up with the CBDT immediately and it has been pursued to hold the Screening Committee Meeting again to promote the officers in the cadre of JCIT whose deficiencies could be removed with the help of the leaders of various Units and concerned officers. The Screening Committee meeting has been convened on 31-03-2016. As the order of promotion requires the kind approval the Hon'ble Finance Minister, GOI, and as he is not in the country till 02-04-2016, the order may be expected only on 04-04-2016.
- iv) The DPC for the promotion of 2011 batch in STS was held on 18-03-2016. All these officers are due for promotion as on 01-04-2016 and a delay in passing the order may jeopardize their

future career prospect. The file regarding the promotion in STS was sent to the o/o of the Hon'ble FM, GOI, by the CBDT but unfortunately, the FM is not in the country till 02-04-2016. In such a scenario, the CHQ took up the issue with the CBDT and the Revenue Secretary and finally, the sanction of the Hon'ble FM, GOI, obtained over mail on 31-03-2016. The order of the STS promotion for the 2011 and earlier batches will be passed on 01-04-2016 and all our members are requested to join on the same day.

- v) The information on the options exercised by the members for AGT 2016 has not been received by the CHQ so far from any Unit. Considering that the process of AGT, 2016 is likely to commence shortly, it is once again requested that the information, **in the formats given in our Communication dated 21-03-2016** (copy enclosed), may be sent to the CHQ, separately for DCIT/ACIT and Addl.CIT/JCIT cadres.

It is once again requested that all the Units may compile, **in the said formats**, the information on the options exercised by the members of their Region that may be available from the compilation of option forms at the respective Pr.CCIT level.



It is to be mentioned that the CHQ keeps receiving transfer requests of individual members, either directly from the members or forwarded by the leaders of some Units. It is to be reiterated that compilation of options exercised by our members, if directly sent to the CHQ by the individual members, is not feasible. **The CHQ has taken a conscious decision that only those cases will be presented and pursued before the Authority that are compiled and sent by the respective Units, officially.** The individual members of every Region are requested to ensure that the information on the options exercised by them is included in the compilation by the respective Units.

Cooperation of all the Units in the above issues will be highly appreciated.
