Sub: CS(MA) Rules 1944 Renewal of name of the AMA for the treatment of Centra Govt. Employees' and Members of their family for the period from 01.08.2019 to 31.07.2020.- Extension thereof - matter regarding

Ref: Circular 1 & 2/2019-20 in F.No. CGEWCC/Kol/16/2019-20/AMA-1/697 dated 02-08-2019 & F.N. CGEWCC/Kol/16/2019-20/AMA-2/705 dated 02-08-2019 respectively

In terms of O.M. No. 9-14025/133/79-MS dated 28.05.1982 of Ministry of Health & Family Planning (Department of Health) and Circular No. 445-Audit/17/87/III-90 (86) dated 10.08.1990 of C&AG and as per Rule 2A (iv) of the CS(MA) Rules 1944, the names of the Private Medical Practitioners were empanelled as Authorized Medical Attendants (AMA) for Central Govt. Employees and their family members as stated in the above referred circulars for the year 2019-20 with a validity up to 31-07-2020. However, due to Covid-19 outbreak throughout the country, several Private Medical Practitioners residing in far off places are not being able to submit their applications for renewal of AMA for the next year.

In view of the above, the existing panel of AMAs, as mentioned in above referred Circulars 1 & 2, the validity of which is going to expire on 31-07-2020, is hereby extended up to 31.10.2020 with all the terms and conditions as mentioned in the above said circulars.
