(D) Voters criterion

The members of the I.T.G.O.A. who have got their promotion and joined the cadre of A.O./P.S./ITO on or before 03-04-2017 and Group A officers who have either joined on or before 03-04-2017 or not made over their offices in W.B. charge before 04-04-2017 on inter – state transfer are eligible to cast their vote in Election.

(E) Filing of Nomination

1. For any particular post of Office-bearer, any proposer or seconder is not eligible either to propose or second the name of persons in excess of the number of the post.
2. For the posts of Executive Committee Members, any proposer or seconder is not eligible either to propose or second in aggregate the names of more than 18 (eighteen) persons.
3. In the case of violation of (1) & (2) above, all such nomination papers will be liable to be cancelled.
