(F) Voters criterion:

The members of the I.T.G.O.A. who have got their promotion and joined the cadre of A.O./P.S./ITO on or before 13-01-2015 and Group A officers who have either joined on or before 13-01-2015 or not made over their offices in W.B. charge before 14-01-2015 on inter – state transfer are eligible to cast their vote in Election.

(G) Filing of Nomination:

- a. For any particular post of Office-bearer, any proposer or seconder is not eligible either to propose or second the name of persons in excess of the number of the post.
- b. For the posts of Executive Committee Members, any proposer or seconder is not eligible either to propose or second in aggregate the names of more than 18 (eighteen) persons.
- c. In the case of violation of (a) & (b) of (G) above, all such nomination papers will be liable to be cancelled.
