## Sub: Due List for the Annual General Transfer in the grade of A.Os/Sr.P.Ss./P.Ss.-2019 matter reg.

Kindly refer to the above.

- 2. I am directed to bring to your kind notice that the due list for the Annual General Transfer-2019 in the grade of A. Os/Sr. P. Ss. /P. Ss. has been prepared. This may be circulated amongst all the A.Os/Sr. P. Ss. /P. Ss. posted under your control.
- 3. If any discrepancy is noted, that may kindly be brought to the notice of this office, so that necessary corrections may be made.
- 4. However, if any officer feels that he/she has any special circumstances viz. medical, physically challenged or any other special reason, to be considered for inclusion or exclusion from the said due list, he/she may submit his/her representation with appropriate supporting evidence within the date mentioned hereunder.
- 5. Names appearing in the due list are not final. Due list may be modified in case of new inputs or if any omission comes to the knowledge of this office.
- 6. In view of the above, I am directed to request you to kindly instruct the reporting officers under your administrative control to submit any objections / representations with proper supporting evidences and to kindly send the suitable applications duly verified by the Head of Office positively by 08.03.2019.
- 7. The normal tenure at a post should ordinarily be of 3 years. The officers should be eligible for transfer when they complete the tenure at a post. However, tenure in a particular PCIT/CIT charge and the post of the post of the state of
- For the purpose of counting of tenure at a post, a period of last 6 months or more in a financial year should be deemed as a full year.

8. Officers who have 3 years or less service left, should be considered for posting to the home town of their choice to the extent possible.

Officers who have 6 months or less service left from the month of AGT, if due for transfer should be accommodated within same DDO charge to avoid difficulty in preparation of pension papers.

- 9. If newly promoted officers have to move out of Kolkata to fill vacant moffusil charges, it should be according to junior in service cum junior in age. However, the officers who have already attained 55 years of age, shall not be considered for such transfer without his/her consent. Tenure of such posting shall not exceed 2 years period.
- 10. Further, it has been decided by the competent authority that for the purpose of such posting in mofussil charges, officers in terms of their status of being junior shall be considered for such posting even if he/she has not completed his tenure in any office in Kolkata.
- 11. No further representations would be entertained from A.Os/Sr.P.Ss./P.Ss after 08.03.2019. However, under extreme circumstances, if the administration feels it is necessary to do so, the same may be considered. The administration also reserves its right to consider any case even if not falling within the parameter of the Transfer/Placement guidelines for administrative convenience. Request for retention of a particular officer on administrative grounds may also be forwarded by 08.03.2019.
