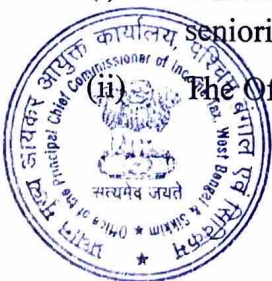

(b) The Adhoc promotion is subject to the following conditions:

(i) The Adhoc promotion shall not confer on the Officials concerned, any right to claim seniority in the grade of ITO or regular promotion as ITO;

(ii) The Officials are liable to be reverted at any time without assigning any reason.



- (iii) The promotion is valid for one year or till their reversion to the feeder cadre or regularization of such promotion, whichever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.
- (iv) The Officials are not entitled to exercise their option provided under F.R.22(1)(a)(1) being adhoc promotion. They will be entitled to exercise their option on their regularization against regular vacancy.

Part-IV:

- (a) The continuation of above promotion both ad hoc and regular is further subject to any other order/judicial pronouncement of any court or instructions/guidelines issued by CBDT/DoPT/HRD in this regard.
- (b) The persons concerned may please note that in the event of their refusing promotion, they would be debarred from promotion for a period of one year from the date of refusal of said promotion or till the next vacancy arises, whichever is later, as per the D.O.P&T's O.M No. 22011/5/86-Estt.(D), dated 10.04.1989 read with O.M. No. 22011/5/91-Estt.(D) dated 27.03.1997.
- (c) The *inter se seniority* of the persons appearing in Part I, II & III of this order, in the grade of Income Tax Officer will be notified separately in due course.
