- 2. I am directed to bring to your kind attention that e-Office allows diarisation of inward receipts, creation of files, movement of receipts of files and finally, the archival of records. With this, the movement of receipts and files becomes seamless and there is more transparency in the system since each and every action taken on a file is recorded electronically. This simplifies decision making, as all the required information is available at a single point.
- 3. The Income Tax Department has implemented e-Office across all CCA regions upto the level of ITO's and above. However, it has been noticed that there has been a limited use of e-office in the field formations across this charge.
- 4. I am, therefore, directed to convey that e-Office to be fully functional in all offices across this region without further delay and after 30.06.2024, all communications/matters /files/letters from the field formations addressed to this office must be submitted through e-Office only. I am also directed to inform that after 30.06.2024, all physical communication/correspondences will be discontinued.
