The President, Shri Mrinal Chanda started the meeting and asked all the members to be present in all the meetings on time, and not to make any side talks. He asked Shri Bhaskar Bhattacharya, General Secretary, to start the meeting.

Secretary: Many work has to be done, which were not done. The work may be divided amongst the members for first tracking the solutions. He proposed to move the proposals.

1. Let the **E.C. meeting be opened to all observers**.

Shri Mrinal Chanda: Proposed to move a resolution regarding this. After taking approval of house this was unanimously approved by the house.

Shri Sanjay Pandey: i) Proposed to circulate the minutes of EC meetings 7 days in advance. ii) If some members want any specific topic to be discussed he/she should communicate the same to the President/Secretary 3 days in advance.

Shri Bhaskar Bhattacharya : 2. The house should resolve to put the auditor on equal footing with the other EC members except for the issue of Spl. CL.

The house unanimously approved this proposal.

Shri Bhaskar Bhattacharyas : 3. Three buildings at this moment are unrepresented in the EC, viz., Uttarapan, Poddar Court & ITAT. Let us form building committee in these buildings and the conveners of these building committee should be appointed as permanent invitees in the EC, till next AGT orders.

The house unanimously approved this move.

Shri Bhaskar Bhattacharya : Proposed at least one EC meeting every month to be rotated amongst all buildings, which may take the formation of a General Body meeting by active involvement of the members. If we want discussion on any specific subject was required the EC Meeting could be held at Aayakar Bhawan.

Shri Avhijit Ghosh: The rotation of the E C meetings amongst the buildings may not be implementable and the time constraint may be a factor.

Shri Amitava Sen; May be the small buildings would be unable to hold the EC meetings due to infrastructural problem. In that case a choice may be given to them and for those buildings which are not able to hold meetings a group of O.B./EC members can visit them separately and sort out their problems.

Shri Goutam Mondal: We must be ensure that a visit to all the buildings and moufossil stations.

Shri Bhaskar Bhattacharya : Let us chalk out a problem and ensure that at least one visit to all mufassil offices by end of February, 2013.

Shri Sumit Roy : Let Amitava Sen & Smt Monasisa Pal Mukherjee be entrusted to chalk out the timetable and place before the house in the next EC meeting.

Shri Goutam Shome: Whether the deadline for completion of time barring assessment has really been pushed back to 31st March., 2013.

Shri Mrinal Chanda: The Chairman has clarified that for proper investigation the deadline is not 31st December, 2012. We should give disposal to cases where we chose not to do any investigation. We should ensure that no file has been left untouched.

Shri Bhaskar Bhattacharya: The intimation of O.B. meetings can be intimated to all E C members so that they can participated in the meetings on their choice.

We should not increase the number of participants in the O.B meetings, we should answer insure the decisions of the O.B. meetings are quickly shared with E.C. members.

Shri Amitava Sen : The real intention behind this move is to break water tight computerization of E.C & O.B.

Shri Avijit Ghosh: Welcomed the above move, we should take lesson from the past and ensure the E.C does not become a body to give stamp of approval on the decision taken by the O.B.

Shri Bhaskar Bhattacherjee : Requested for participation of E.C. members in JCA meetings. This is found to enrich the discussions as increased number of members is found to give more input of ideas.

The proposal of Secretary regarding OB. meetings and JCA meetings was unanimously approved.

Shri B.Bhattacherjee : Let all E.C members unify and in turn keep contact with the representative of North Bengal & South Bengal Units.

Let distribute the work load and added responsibility. All the members should take decisions in their individual capacity will move to all buildings between January and February, 2013 to form building committee of respective buildings. Let the activity in their respective seat prior to these meeting and decide upon the composition of the Building committee. In the last committee individually we moved to solve the problems which could not always fructify. Let us now distribute the work load among the E.C. member. We should make it al habit to be present in Association Room during office hours and after 5 pm so the members do not return from doors of the Association Room. The E.C. members currently in Aayakar Bhawan should take primary role in this.
