CIRCULAR

Sub. : Circulation of revised tentative seniority list in the grade of Administrative Officer, Grade-II pertaining to panel/vacancy year 2013-14 to 2021, in the region of West Bengal & Sikkim - matter reg.

The seniority list in the grade of Administrative Officer, Grade-III, has been revised upto vacancy year 2016-17 vide circular F. No. PCCIT/WBS/Admn/DC/Est(Gz)/109/AO(DPC)/2021-22/10713 dated 02.12.2021.

In view of such revision of seniority in the grade of Administrative Officer, Grade-III, which constitutes the feeder grade for promotion to the grade of Administrative Officer, Grade-II, the revised panels for promotion to the grade of AO, Grade-II drawn up in the review DPC meeting 18.08.2017 pertaining to panel/vacancy years 2013-14 to 2016-17 have again been revised by conducting a DPC meeting on 02.12.2021.
