Part-I : PROMOTION

- (a) In pursuance to the Recruitment Rules published in Part-II, Section-3, Subsection (i) of Gazette of India on 04.01.2005 and sent vide Board's letter dated 12.01.2005 issued from F.No.A-12018/1/2003-Ad.VI the following **Administrative Officers Gr-III**, is hereby promoted to the post of **Administrative Officer Gr-II** in the Pay Level 8 (Pre-revised Pay Band Rs.9300 – 34800/- with Grade Pay Rs.4800/-), against the vacancies for the R.Y. 2016-17 with immediate effect and until further orders:

- (b) The inter-se-seniority of the above appointees will be fixed in accordance with the instructions contained in Govt. of India, DOP&T M.No. 20011/1/2001-Estt(D) dated 21.01.2002.
- (c) The above persons are hereby asked to exercise their option within 1 (one) month of the date of promotion in the matter of fixation of pay on such promotion in terms of Para-3 of the Ministry of Personnel, Public Grievances & Pension (Deptt. of Personnel & Training) Office Memorandum No. 13/2/97-Estt. (Pay-I) dated 12.12.1997.
- (d) The above officers promoted to the post of AO Grade-II vide this order is liable to be reverted to the post of A.O Grade- III without prior notice at any time.
- (e) The persons concerned should note that in the event of his refusal of promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. No. already cited above, he would be debarred from promotion for a period of one year from the date of refusal of said promotion or till a next vacancy arises, which ever is later, as per the D.O.P & T's O.M.No.22011/5/91-Estt.(D) dated 27.03.1997.

Part-II : POSTING :

- (i) On promotion as AO Gr.-II the above named officers are posted in the same office where he was posted before the promotion and shall perform the duties of AO Gr.-II in addition to their earlier duties assigned to them with effect from the date they take up the charge and until further orders.
- (ii) Posting on promotion mentioned in this order is purely temporary and the officer is liable to be transferred within West Bengal Region in Annual General Transfer.
