Part-I: Ad-hoc Promotion

The following **Inspectors of Income-tax** are hereby appointed on promotion as **Income-tax Officer** in the Pay Level 8 (Pre-revised Pay Band Rs.9300 – 34800/- with Grade Pay Rs.4800/-) purely on **Ad-hoc** basis with effect from the date of their joining on such promotion at the charges mentioned against their names at Part-III of this order.

2. The Ad hoc promotions are subject to the following conditions:

- The Ad hoc promotion shall not confer on the officials concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;
- The officials are liable to be reverted at any time without assigning any reason.
- The promotion is valid for one year or till their reversion to the feeder cadre or regularization of such promotion, whichever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.



- (iv) The officials are not entitled to exercise the option provided under F.R.22(1)(a)(1) being ad-hoc promotion. They will be entitled to exercise the option on the regularization against regular vacancy.

3. The continuation of above ad hoc promotion is further subject to:
- Final outcome of SLP(C) 30621 of 2011, Jarnail Singh and others vs Lachhmi Narain Gupta and others, still pending before the Supreme court of India.
 - Implementation of any instructions/guidelines which may be issued by CBDT/HRD in compliance to the judgement delivered by the Hon'ble Supreme Court in the case of Pratibha Rani & Ors, Versus Union of India & Ors.
 - Any other order/judicial pronouncement on these issues.
