- 2. The Adhoc promotions are subject to the following conditions:
- (i) The Adhoc promotion shall not confer on the officials concerned any right to claim seniority in the grade of AO, Grade-III or regular promotion as AO, Grade-III.
- (ii) The officials are liable to be reverted at any time without assigning any reason,
- (iii) The promotion is valid for one year or till their reversion to the feeder cadre or regularisation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per releavent rules.
- (iv) The officials are not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. They will be entitled to exercise the option on the regularization against regular vacancy.
- The promotions of the above officials are based on revised seniority list published after giving effect to the decision of N.R.Parmar and Ors. Vs Union of India and Ors. and is subject to change in seniority of any official subsequent to any representation received later on by this office and/or decision of any proceedings pending before any Tribunal/Court/CBDT/DoPT;
- 4. The above promotions are made against the existing Vacancies.
- 5. This promotion is subject to any subsequent O.M/clarification/ instruction from DoP&T/CBDT regarding the procedure of implementation of such judgement of the Hon'ble Supreme Court dated 26.09.2018 in SLP(C) No.30621/2011, or any such judgement of the Supreme Court in this regard, the above officials are liable to be reverted at any time without assigning any reason, as a consequence of it.
