5.1 In addition to the above-mentioned conditions, the promotions of the above officials are purely provisional and are liable to be reverted to their present cadre without assigning any reason whatsoever including the following conditions:-

if any candidate is omitted for any reason becomes eligible for promotion subsequently;

(ii) Their seniority will be liable for reconsideration/refixation in the event of any claim of seniority that may be filed at any point of time, upon being found correct, with reference to the records that the claim is correct:
