**Part-I : PROMOTION :**

(d) The officials concerned are liable to be reverted without prior notice at any time. Their posting on promotion are purely temporary and they are liable to be transferred within West Bengal at any time.

(e) The persons concerned may please note that in the event of their refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. 
