## Subject: Discrepancies in statistics – Arrear and current Demand reported in CAP-I and the CPC - Regarding. +++++

Kindly refer to the aforementioned subject.

A comparative study with respect to the demand figures as on 31.3.2016 and 31.03.2017 in respect of your region conducted by the Directorate of O & MS, based on your region's CAP-I report vis-à-vis data obtained from CPC-ITR, Bengaluru (both arrear and current) shows that there is a marked variation in the figures of the amount of demand as reported in CAP-1 statement and the data appearing on CPC portal. The variation may kindly be seen in the Table below, as follows:

The Board has desired that this variation/difference should be explained and 3. strictly reconciled at the earliest. I shall therefore be grateful if necessary directions are issued to all concerned to ensure that the figures of arrear demand as available with them are duly reconciled with the figures of CPC-ITR, Bengaluru. The exercise

of reconciliation may kindly be completed by 31.08.2017 positively and a report in this regard sent to my office, along with the reason for the variation/discrepancies occurring in the statistics.
