In pursuance of the Recruitment Rules Part-II, Section 3, Sub-section-(i) of Gazette of India on 14.04.2007 as sent to this office vide Board's letter dated 26.06.2007 issued from F.No.A-12018/02/2004-Ad-VI(A), the following Private Secretary is hereby promoted to the grade of Senior Private Secretary in the Pay Band Rs.9,300 – 34,800/-, Grade Pay Rs.4800/-, against the vacancies for the R.Y. 2015-16, with immediate effect and until further orders:

(a) The inter-se-seniority of the above officers will be fixed in accordance with the instructions contained in Govt. of India, DOP&T OM.No.20011/1/2001-Estt(D) dated 21.01.2002.

(b) The above person may exercise option under FR 22, within one(1) month from the date of this order, to have their pay fixed either with effect from the date of appointment or with effect from the date of accrual of next increment in the feeder grade. Option once exercised shall be final. This is in terms of Para-3 of the Ministry of Personnel, Public Grievances & Pension (Deptt. of Personnel & Training) Office Memorandum No. 13/2/97-Estt. (Pay-I) dated 12.12.1997.

(c) The above officers promoted to the post of Senior Private Secretary vide this order are liable to be reverted to the post of Private Secretary without prior notice at any time.

(d) The persons concerned will please note that in the event of their refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. No. already cited above he would be debarred from promotion for a period of one year from the date of refusal of said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M.No.22011/5/91-Estt.(D) dated 27.03.1997.

- (i) The above mentioned Senior Private Secretaries, is hereby ordered to continue at his present place of posting as Sr. P.S.(OSD) until further orders.
