2. Posting:

On promotion, the official will continue to discharge their functions and duties on *in situ* basis at her respective present office(s), until further orders.

- 3. The official is informed that their seniority is liable to be changed due to judicial/administrative rders.
- 4. The appointment is purely on **Adhoc** basis and the official is liable for reversion at any time, if found necessary.
- 5. The Adhoc promotion is subject to the following conditions:
- The Adhoc promotion shall not confer on the official concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;
- (ii) The official is liable to be reverted at any time without assigning any reason,
