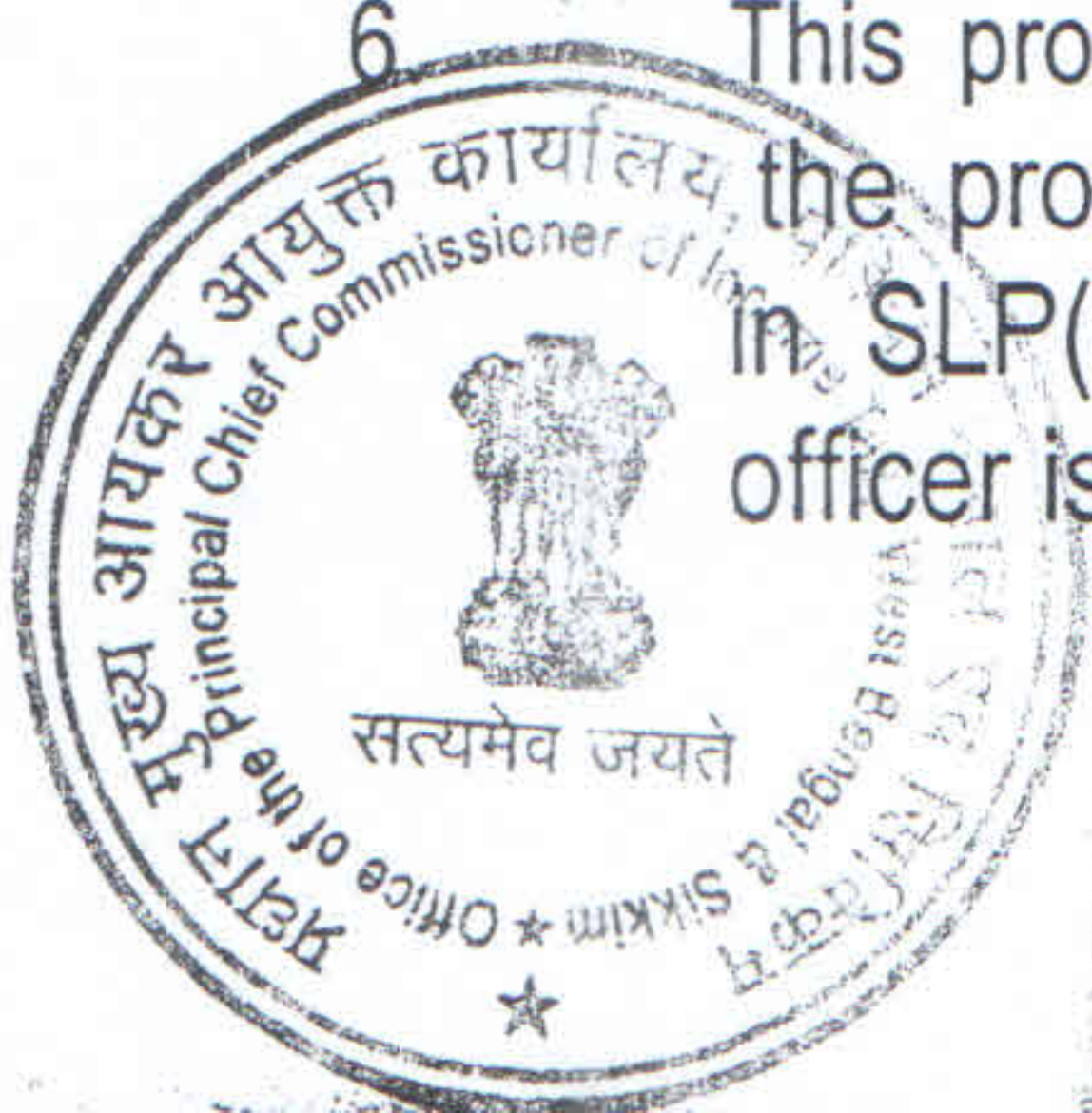

**PROMOTION:**

In pursuance to the Recruitment Rules published in Part-II, Section-3, Subsection (i) of Gazette of India on 04.01.2005 and sent vide Board's letter dated 12.01.2005 issued from F.No.A-12018/1/2003-Ad.VI the following **Administrative Officer Gr-III**, is hereby promoted to the post of **Administrative Officer Gr-II** in the Pay Level 8 (Pre-revised Pay Band Rs.9300 – 34800/- with Grade Pay Rs.4800/-), on **Ad-hoc** basis against Vacancy Year 2019.

2. **Posting:** On promotion, the officer will continue to discharge his functions and duties on *in situ* basis at his respective present office(s), until further orders.
3. The appointment is purely on **Adhoc** basis and the officer is liable for reversion at any time, if found necessary.
4. The Adhoc promotion is subject to the following conditions:
  - (i) The Adhoc promotion shall not confer on the officer concerned any right to claim seniority in the grade of AO, Grade-II or regular promotion as AO, Grade-II;
  - (ii) The officer is liable to be reverted at any time without assigning any reason,
  - (iii) The promotion is valid for one year in terms of Para No.7 of DoPT OM No.28036/1/2001-Estt.(D), dated 23.07.2001.
  - (iv) The officer is not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. He will be entitled to exercise the option on the regularization against regular vacancy.
- 4.1 In addition to the above-mentioned conditions, the promotions of the above officer is purely provisional and is liable to be reverted to his present cadre without assigning any reason whatsoever including the following conditions:-
  - (i) If after a review of vacancies, it is found that his promotion is in excess of the vacancies available or if any candidate is omitted for any reason becomes eligible for promotion subsequently;
  - (ii) Their seniority will be liable for reconsideration/refixation in the event of any claim of seniority that may be filed at any point of time, upon being found correct, with reference to the records that the claim is correct;
  - (iii) The promotion of the above officer is based on revised seniority list published after giving effect to the decision of N.R.Parmar and Ors. Vs Union of India and Ors. and is subject to change in seniority of any official subsequent to any representation received later on by this office and/or decision of any proceedings pending before any Tribunal/Court/CBDT/DoPT;
- 5 The above promotion is made against the Vacancy Year 2019 on ad-hoc basis.
- 6 This promotion is subject to any subsequent O.M/clarification/ instruction from DoP&T/CBDT regarding the procedure of implementation of such judgement of the Hon'ble Supreme Court dated 26.09.2018 in SLP(C) No.30621/2011, or any such judgement of the Supreme Court in this regard, the above officer is liable to be reverted at any time without assigning any reason, as a consequence of it.





7. He is however informed that he is liable to be reverted to the lower post if after review of the vacancies or for administrative reasons or in compliance to any Court's order it is considered necessary to revert them.
8. The officer who has been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, will not be eligible for any pay fixation now.
9. The person concerned may please note that in the event of his refusing promotion he/she would be debarred from promotion for a period of one year from the date of refusal of said promotion or till the next vacancy arises, whichever is later, as per the D.O.P&T's O.M.No. 22011/5/86-Estt.(D), dated 10.04.1989 read with 22011/5/91-Estt.(D) dated 27.03.1997.
10. On promotion as AO Gr.-II the above named officer is posted in the same office where he was posted before the promotion and shall perform the duties of AO Gr.-II in addition to his earlier duties assigned to them with effect from the date he take up the charge and until further orders.
11. Posting on promotion mentioned in this order is purely temporary and the officer is liable to be transferred within West Bengal Region in future.
