Sub : Grant of pay of Rs.5400/- in PB-2 on non-functional basis to Group-B officers

As per information received from the D.C..T. Hqrs. (Admn. & Vig.) Kolkata vide letter in F.No.2E/28/NFSG(ITO)/2015-16/1298 date 18/5/2015, the officers named in the table below have been promoted to the post of 'Income Tax Officer' vide order no 64 of 2011 date 01/6/2011 and qualify for grant of Grade Pay of Rs.5400 in PB-2 on non-functional basis to Group B officers in the Department.

In terms of the communication from DIT (HRD), CBDT dated 14/09/2009, the officers named below may be allowed to draw pay of Rs.5400/- in PB-2, w.e.f. the respective date of completion of four(4) years of regular service in the post of ITO, if it is found by their respective Head of Office / Department that the officer has completed 4 years of regular service as Income Tax officer irrespective of the pay scale attached to the post, and this enhancement of pay has not been granted earlier.
