Sub:- Withdrawal of agitation programme - matter regarding.

- Ref:- (I) Our Letter dated 15/05/2018 intimating initiation of programme of agitation by JCA, WB and Sikkim.
 - (II) Our letter dated 22/05/2018 intimating intensification of ongoing agitation under the banner of JCA, WB & Sikkim.

Kindly refer to the above.

Subsequent to your meetings with the Joint Convenors of Central JCA, New Delhi held on 29/05/2018 and 30/05/2018, the state JCA held a general meeting of its members at Multipurpose Hall, Aaykar Bhawan, Kolkata on 31/05/2018. It has been decided in the said meeting to withdraw the ongoing agitation programme on the basis of the outcomes of the meetings mentioned above.

The JCA, WB expects that all the agreements arrived in the meetings will be incorporated in the revised Transfer & Posting (T & P) Policy of ITOs and Group C Employees for the Year 2018 – 19. The JCA, WB unit still holds the view that there is no need to bring about the changes regarding decentralization of transfer posting of ITOs. We also hold the view that the existing policy of postings of office bearers of the recognized associations should continue. We strongly believe that these clauses are integral part of the time tested T & P policy existing in this region for the last twenty years.

We request your good self to ensure the revised T & P policy as well as the T & P orders are issued at the earliest. However, if there is any deviation from the revised policy, the associations reserve every right to protest against the same. Further, this T & P policy should be reviewed in the next year on the basis of experience and outcomes of the current year.
