

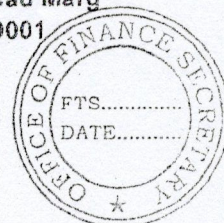

Dear

Department of Posts under provisions of Section 4 of Indian Post Office Act, 1890 is given exclusive privilege of conveying letters in India. In other words, the India Post Office is mandated to discharge the responsibility of Universal Service Obligation (USO) in providing mails conveyance and delivery even in the remotest areas. This has turned India Post into the largest postal network in the world, a fact for which every Indian is today proud of.

2. India Post is now on the cusp of technological transformation. To our premium service Speed Post, we have added on-line tracking facility, made provisions for rebate for bulk users, provided free pick-up, offered credit facility in the shape of Book Now Pay Later (BNPL) and we have been consistently living up to our promise. I am happy to recount that on account of consistent reliable performance, CAG in their Report No.20 of 2015 (Chapter 3) – Union Government on Communications and IT sector laid in the Parliament in May 2011 have treated Speed Post as best in the market. The print media had also prominently covered it at national level.

3. There is another aspect I am going to touch in this connection. While advertisements of Government Departments / Public-funded organizations are expected to be routed through DAVP, while Government servants on official tours are directed to travel by official carrier Air India, while the official procurement is made through GeM portal, India Post should likewise legitimately count on the patronage of the Government organizations like yours for conveying their entire mails through India Post. Hence, I would pitch in with the best offer of Speed Post and further request you to bring the legal provisions as cited above to the notice of those in your organization, who are entrusted to decide as to whether mails are to be sent through private couriers or through India Post's premium service Speed Post. We assure to provide the best in class service and expecting a positive response in this regard. Shri V.P.
