

OFFICE ORDER NO. 90 of 2025

In continuation of this Office's Order No. 15 of 2025 dated 28.01.2025 and Office Order No. 39 of 2025 dated 17.02.2025, the President is pleased to allow Shri Amal Kumar Roy (Sen. No. 2494; AIISL-2012), ITO, WB & Sikkim, to forego his promotion to the grade of Assistant Commissioner of Income Tax on regular basis issued vide Office Order No. 350 of 2024 dated 31.12.2024.

2 His name stands deleted from the Office Order No. 350 of 2024 dated 31.12.2024. As per DOPT's OM No. 22011/5/86-Estt.(D) dated 10.04.1989, **he is debarred for regular promotion to the grade of Assistant Commissioner of Income Tax for a period of one year from the date of refusal of promotion or till a next vacancy arises, whichever is later. On the eventual promotion to the higher grade such Government servant will lose seniority vis-à-vis his juniors promoted to the higher grade earlier irrespective of the fact whether the posts in question are filled by the selection or otherwise.**
