Order No. 110 of 2009

In pursuance of Government of India, Department of Expenditure Resolution No 1/1/2008- IC dated 29<sup>th</sup> August 2008 notifying acceptance of recommendations of 6<sup>th</sup> Central Pay Commission, the Directorate of Income Tax (HRD), New Delhi has clarified vide its letter dated 14.09.2009 that the grant of the higher grade pay of Rs 5,400/- in PB- 2 on non functional basis is not linked to vacancy and may be given retrospectively w.e.f. 01.01.2006 provided the officer concerned (i) has completed 4 years of regular service as an Income-tax Officer, irrespective of the pay scale attached to the post, and (ii) is clear from vigilance angle.

2. In the light of the above, it is hereby notified that the following **Income-tax Officers** are eligible to the higher grade pay of **Rs.5,400/-** in **PB- 2** with effect from the date, falling on or after 01 01 2006, on which they have completed 4 years of regular service as Income-tax Officer :-
