



**ORDER No. 138 of 2016**

3. The above list of officers does not purport to be a seniority list and the *inter se* seniority between the Promotee and the Direct Recruits will be governed by the relevant provisions of the Indian Revenue Service Rules, 2015.



CCsIT concerned, to which the officers are posted, shall ensure that they are clear from vigilance angle, no disciplinary/ criminal proceedings are pending against them and are not under suspension before they are allowed to assume charge as ACIT on *in situ* basis and till their formal posting is decided by the Competent Authority/ Placement Committee.

5. Such appointments shall not confer any right to the officers for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DOP&T as contained in OM No. 28036/8/87-Estt.(D) dated 30.03.1988 and instructions issued by Government from time to time.


