3. The tenure of this freshly re-constituted CBDT SCC will be upto **31.03.2026**. Further, the Committee will co-opt at least one Officer and one staff member as members of the CBDT SCC, being representative Members of the respective Officer's / staff association, as nominated by respective Associations.
4. The CBDT SCC so constituted would have the following mandate: -
  - a) Organizing intra-departmental Sports activities.
  - b) For Monitoring effective budgeting and utilization of funds allocated under the head 'contributions' for sports and cultural activities.
  - c) For strategic planning in Sports Recruitment, in coordination with Cadre Controlling Authorities, to help set up regional and National teams.
  - d) For Organizing Intra departmental cultural activities for the selection of representative participants from the Income-tax department in various cultural events/competitions.
  - e) To consider and recommend proposals to the executive committees of the Income-tax Welfare Fund, for disbursement from the fund, for recreation and other outdoor activities for the Officers/officials, providing of scholarship for meritorious sportsperson and to monitor the proper utilization of the amounts so disbursed from the Welfare fund.
  - f) To set up sub-committees on need basis for various disciplines and activities, for the furtherance of its objectives.
5. The NCs will also nominate two or more Asstt. National Coordinators for respective Sports / Cultural, on need basis, for facilitating in proper coordination and organization of associated events, in accordance with the Annual plan of CBDT SCC.
