Subject: Rollout of ITBA ASK on all India level and stopping Sevottam application w. e. f. 01-05-2017 – Reg....

Madam/Sir,

Kindly refer to Sevottam instruction no. 8 dated 23/06/2016 and ITBA-ASK instruction no. 1 and 2 dated 29/08/2016 and 18/11/2016 respectively (copies enclosed as annexure-'A').

- 2. On analysis, it found that ITBA-ASK is being used at 114 locations only while Sevottam is working at 350 locations across the country. ITBA-ASK should be made operational at all the locations where Sevottam is operational after completion of all pre-requisites. List of building locations where Sevottam and ITBA-ASK are operational is enclosed as annexure-'B' for ready reference
- 3. It is therefore, requested to kindly complete all pre-requisites on priority and start receiving daks and paper ITRs through ITBA-ASK only. Sevottam application for receipt part will not be available from **01.05.2017** onwards. However officers would be able to login into Sevottam for resolution of daks received till 30.04.2017. This may kindly be brought to the notice of all the ASK centres and officers under your region.
