Kind reference is invited to Board's OMs of even number dated 4<sup>th</sup> April, 2016 and 1<sup>st</sup> June, 2016 on the subject cited above.

- 2. In the OM dated 4<sup>th</sup> April, 2016 it was requested that Members/Pr. CCsIT/ Pr. DGsIT should personally examine 10 grievances every week and similarly Pr. CsIT/ CsIT should examine 20/30 grievances respectively every week as per the directions of Hon'ble Prime Minister communicated during the PRAGATI meetings of January and March, 2016.
- 3. It was also requested that a monthly report about such monitoring of grievances should be forwarded to the Zonal Members by the Pr. CCsIT/ Pr. DGsIT by 5<sup>th</sup> of succeeding month. All the Members of the Board were requested to forward a consolidated report to Chairman, CBDT for onward submission.
- 4. In the OM dated 1<sup>st</sup> June, 2016 it was requested that report about such personal monitoring of public grievances may be submitted in the following proforma for compilation by the Centralized Grievance Cell. The reports were to be forwarded to the e-mail address <a href="mailto:binod.sinha@nic.in">binod.sinha@nic.in</a>.

- 5. However, it is seen from the reports received so far that several Pr. CCsIT regions have not been sending these reports. For example, reports were received from 10 Pr. CCsIT regions for the month of June, 2016 while reports from 8 Pr. CCsIT regions have been received for the months of July and August, 2016. It may kindly be noted that the details of personal monitoring of grievances are to be uploaded on PRAGATI / e-Samiksha portal on a monthly basis and if reports are not received from all the regions, it negatively impacts the overall picture of the department in this area of work.
- 6. It is, therefore, kindly requested that reports regarding personal monitoring of grievances may be forwarded by all Pr. CCsIT regions latest by 5<sup>th</sup> of the succeeding month in the given proforma by e-mail as mentioned above so that the work done by various field officers is properly reflected in PRAGATI /e-Samiksha portal.
