Sub : Diversion of some posts of ITO's from salary charges to assessment charges – request regarding...

Kindly refer to the above.

1. Recently, we have received feedback from the various none corporate assessment charges that the work-load in some of the charges are un-bearable and even more than 3 / 4 times of the work load earmarked for an assessment charge at the time of re-structuring of the Department in 2001. So, the officers are reeling under work pressure and get inhumanly stressed.

2. Hence, in the interest of the revenue and better man-management, it is proposed that the following posts may be created by splitting the assessment charges diverting suitable posts from elsewhere. It is needless to say that creation of posts in assessment charges may lead to better handling of assessment cases and result in augmentation of revenue.

- 2. The ITO(TDS), Haldia and ITO(TDS), Nadia are holding the jurisdiction over Midnapore and Murshidabad Districts respectively which are geographically too far away from Haldia and Nadia. Also, the districts of Midnapore and Murshidabad have enough potential to have a separate TDS charge of their own.
- 3. In view of the above discussion, it is requested that 5(five) posts in assessment charges and 2(two) posts in TDS charges may kindly be created. The above exercise will not only create a conducive working environment for an officer but also increase the effectiveness of the Department.
