(b) The above person may exercise option under FR 22, within one(1) month from the date of this order, to have her pay fixed either with effect from the date of appointment or with effect from the date of accrual of next increment in the feeder grade. Option once exercised shall be final. This is in terms of Para-3 of the Ministry of Personnel, Public Grievances & Pension (Deptt. of Personnel & Training) Office Memorandum No. 13/2/97-Estt. (Pay-I) dated 12.12.1997.

(c) The above officer promoted to the post of Senior Private Secretary vide this order is liable to be reverted to the post of Private Secretary without prior notice at any time.

(d) The person concerned will please note that in the event of her refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. No. already cited above he would be debarred from promotion for a period of one year from the date of refusal of said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M.No.22011/5/91-Estt.(D) dated 27.03.1997.

- (i) The above mentioned Senior Private Secretary, is hereby ordered to continue at his present place of posting as Sr. P.S to PCIT Jalpaiguri, until further orders.
