All the Pr. Chief Commissioner of Income Tax(CCA),

**Sub: Conveying Ex-post-facto approval of DoPT for extension of Ad-hoc promotion in the cadres of Group-B Gazetted Officers-reg.**

Madam/Sir,

With regard to the aforementioned subject, I am directed to convey the Ex-post-facto approval accorded by the DoPT vide ID note no. 11036/O1/2024-PP(D-Promotion) (e-file no.- 3189880) dated 11.11.2024 for extension of ad-hoc promotion in respect of officers as per annexure in the cadres of Group-B Gazetted. The period for which ex-post-facto approval for extension of ad-hoc promotion accorded by the DoPT in respect of **203** Gazetted Officers (ITO, PS & AO, Gr.II) vide ID note referred to above are mentioned against the names of the each officers as per Annexure enclosed with this letter. **The formal order of extension of ad-hoc promotion in respect of these officers will be issued by the concerned PCCsIT(CCA).**

2. The extension is subject to the following conditions: --

(i) The period of extension of ad-hoc promotion is mentioned against the names of the each officers as per Annexure enclosed with this letter.

(ii) The period of extension of ad-hoc appointment/promotion as mentioned against the name of the officers as per Annexure shall not confer on the appointees any right to continue in the present grade/post indefinitely or for inclusion in the panel for regular promotion or to claim seniority in the present grade/post being held on ad-hoc basis.

(iii) The Ex-post facto approval for extension of ad-hoc promotion accorded by the DoPT for the period relates before the regularization of officers in respective cadres as per details given in the Annexure. The date of regularization of the Officers in respective cadres as reported by the concerned CCA Regions is also mentioned against the names of the each officers as per Annexure enclosed.

(iv) The ad-hoc appointment/promotion shall be governed by the instructions of DOPT OM Nos. No. 28036/8/87-Estt. (D) dated 30.03.1988, No.28036/1/2012-Estt(D) dated 03.04.2013 and instructions issued by the Government from time to time.

3. In view of the aforesaid, I am directed to request that consequent upon Ex-post-facto approval accorded by the DoPT referred to the above, **the concerned PCCsIT(CCA) may issue necessary order in this regard.**


