IN THE LUNCH HOUR DEMONSTRATION HELD ON 19<sup>th</sup> July 2024**

This meeting is organized today (on 19<sup>th</sup> July 2024) in front of the o/o the \_\_\_\_\_ Region by the JCA, \_\_\_\_\_ Unit at the call of the Central JCA to hold a Lunch Hour Demonstration in support of 7 point charter of demands.

The meeting unanimously resolves to appeal to the Cabinet Secretary, Govt. of India, New Delhi to take appropriate measure to settle the following issues/demands early:

**Issues/Demands:**

1. *Immediate Constitution of 8<sup>th</sup> Central Pay Commission.*
2. *Scrap NPS, Restore OPS for all employees.*
3. *To Release 18 months DA/DR which was frozen during the COVID -19 Pandemic to employees and Pensioners, Restoration of commuted part of pension after 12 years instead of 15 years at present.*
4. *Remove 5% ceiling on Compassionate Appointment, grant compassionate appointment to all the wards/Dependents of the deceased employee.*
5. *Fill up all vacant posts of all the cadres in all Departments, stop outsourcing and contractorization in Government Departments.*
6. **Ensure Democratic functioning of Association/Federations as per provisions of JCM mechanism:**
  - (A) *Grant recognition to Association/Federations which are pending, Withdraw the de-recognition orders of Postal Gr. C Union, NFPE, ISROSA.*
  - (B) *Stop imposition of Rule 151(c) on service Association/Federations.*
7. **Regularize Casual, Contractual labours and GDS employees, grant equal status to employees of Autonomous Bodies to that of CG Employees.**
