2. Posting:

- 3. The officials are informed that their seniority is liable to be changed due to judicial/administrative orders.
- The appointment is purely on Adhoc basis and the official is liable for reversion at any time, if found necessary.
- 5. The Adhoc promotions are subject to the following conditions:
- (i) The Adhoc promotion shall not confer on the officials concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;

The officials are liable to be reverted at any time without assigning any reason, (ii)

The promotion is valid for one year in terms of Para No.7 of DoPT OM No.28036/1/2001-Estt.(D), (iii)dated 23.07.2001.

- The officials are not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc (IV)promotion. They will be entitled to exercise the option on the regularization against regular vacancy.
- In addition to the above-mentioned conditions, the promotions of the above officials are purely 5.1 provisional and are liable to be reverted to their present cadre without assigning any reason whatsoever including the following conditions:-

- They are however informed that they are liable to be reverted to the lower post if after review of the 8. vacancies or for administrative reasons or in compliance to any Court's order it is considered necessary to revert them.
- The officials who have been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, will not be eligible for any pay fixation now.
