Kind attention is drawn to letter of AAD, ACR (CELL) vide F. No. E-61 (1-18) /ACRs of ITOs/PR,PP&OL/2014-15 dated 30th June, 2014 and subsequent reminder letters dated 22nd October, 2014 & 15th January, 2015 on the subject mentioned above and also to the list of deficient ACRs/ APARs as displayed on the official website : www.irsofficersonline.gov.in on 29th January, 2015.

Vide my predecessor's D.O. letter dated 5th March,2015, it was requested that immediate attention may kindly be given to remove deficiencies in APARs of ITOs of 2001 and 2002 batches, being the first list of deficiencies.
