Part-I : PROMOTION:

- (a) In pursuance to the Recruitment Rules published in Part-II, Section-3, Subsection (i) of Gazette of India on 04.01.2005 and sent vide Board's letter dated 12.01.2005 issued from F.No.A-12018/1/2003-Ad.VI, the following **Office Superintendents**, are hereby promoted to the post of **Administrative Officer Gr-III** in the Pay Level -7 (Pre revised Pay Band 2: Rs.9,300 – 34,800/-, Grade Pay Rs.4600/-) on regular basis against the vacancies available for the Vacancy Year 2017-18.

- (b) The promotion to the post of Administrative Officer Gr-III in case of the above named officials shall become effective from the date of his joining as Administrative Officer Gr-III.
- (c) In the case of the incumbent, appearing at Sl. No.2 of the above table, who is on deputation on the date of issue of the order, the promotion shall take effect only as and when he report back and join in his parent department in the feeder grade (O.S.), as at present he is not available to join on such promotion in the grade of A.O., Gr.III.
- (d) The inter-se-seniority of the above appointees will be fixed in accordance with the instructions contained in Govt. of India, DOP&T OM.No.20011/1/2001-Estt (D) dated 21.01.2002.
- (e) The above persons are hereby asked to exercise his option within 1 (one) month of the date of promotion in the matter of fixation of pay on such promotion in terms of Para-3 of the Ministry of Personnel, Public Grievances Pension (Deptt. of Personnel & Training) Office Memorandum No. 13/2/97-Estt. (Pay-I) dated 12.12.1997.
- (f) The officials concerned are liable to be reverted without prior notice at any time. The posting on promotion is purely temporary and they are liable to be transferred within West Bengal at any point of time.
- (g) The persons concerned may please note that in the event of their refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. No. already cited above he would be debarred from promotion for a period of one year from the date of refusal of said promotion or till the next vacancy arises, whichever is later, as per the D.O.P&T's O.M.No.22011/5/91-Estt.(D) dated 27.03.1997.
